FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM
OF
YOGI BEAR'S JELLYSTONE PARK CAMP-RESORT (APOPKA), A CONDOMINIUM

THIS FIRST AMENDMENT to Declaration of Condominium of Yogi Bear's Jellystone Park Camp-Resort (Apopka), a Condominium, hereinafter "First Amendment", is made this 29th day of March, 1983, by SUN RESORTS, INC., a Florida corporation, and its successors and assigns, hereinafter called the "Developer".

WHEREIN, the Developer makes the following amendment:

Paragraph 17.11 of said Declaration being recorded in Official Records Book 3347, Pages 2482 through 2581, is hereby amended to read as follows:

17.11. No Warranty Unless Expressed Herein. The Developer specifically disclaims any intent to have made any warranty or representation in connection with the Condominium Property or the Condominium documents except as specifically set forth herein and no person shall rely upon any warranty or representation, oral or otherwise, not so specifically made herein. Any estimates of Common Expenses, taxes or other charges are deemed accurate, but no warranty or guarantee is made or intended nor may one be relied upon.

Developer hereby grants a warranty as to Developer installed concrete slabs on the Units. The warranty shall be for a period of three (3) years from the date Developer gives notice of the intended conversion pursuant to Florida Statute 718.608. This warranty is for structural fitness, and Developer will repair or replace any slabs which it installed which become inusable within said three (3) year warranty period.
